 "Goods" means all Goods or Services supplied by MAUS to the Client at the Client's request from time to time (where the context so permits the terms 'Goods' or 'Services' shall be interchangeable for the other).

 "Equipment" means all Equipment including any accessories supplied on hire by MAUS to the Client (and where the context so permits shall include any supply of Services). The Equipment shall be as described on the invoices, quotation, authority to hire, or any other work authorisation form provided by MAUS to the Client.

 "Price" means the Price payable for the Goods as agreed between MAUS and the Client in accordance with clause 4 below.

- Acceptance
 The Client is taken to have exclusively accepted and is immediately bound, jointly and severally, by these terms and conditions if the Client places an order for or accepts delivery of the Goods/Equipment.
 These terms and conditions may only be amended with MAUS' consent in writing and shall prevail to the extent of any inconsistency with any other document or agreement between the Client and MAUS.

Change in Control
The Client shall give MAUS not less than fourteen (14) days prior written notice of any proposed change of ownership of the Client and/or any other change in the Client's details (including but not limited to, changes in the Client's name, address, contact phone or fax number/s, or business practice). The Client shall be liable for any loss incurred by MAUS as a result of the Client's failure to comply with this clause.

Price and Payment

 At MAUS' sole discretion the Price shall be either:
 (a) as indicated on any invoice provided by MAUS to the Client; or
 (b) the Price as at the date of delivery of the Goods/Equipment according to

 Unless otherwise stated the Price does not include GST. In addition to the Price the Client must pay to MAUS an amount equal to any GST MAUS must pay for any supply by MAUS under this or any other agreement for the sale of the Goods/hire of the Equipment. The Client must pay GST, without deduction or set off of any other amounts, at the same time and on the same basis as the

 The Client must take delivery by receipt or collection of the Goods/Equipment whenever either is tendered for delivery. In the event that the Client is unable to take delivery of the Goods as arranged then MAUS shall be entitled to charge a

If MAUS is required to replace the Goods under this clause or the CCA, but is unable to do so, MAUS may refund any money the Client has paid for the Goods.
